I, Sri Abdul Gaffar son of Lt. Abdul Khaleque, S.M Gopalpur C.C.C alongwith Sri Dilip Kumar Shaw son of Sri Beni Shaw, S.A.E, Sajal Kumar Mitra son of Lt. Rati Kanta Mitra, T.S.H. both of Gopalpur C.C.C went to inspect the Electric connection of the premises of Sri Shyamal Kabiraj son of Santosh Kabiraj at Village-Baramana (Sahamana), P.O.-Radhakantapur, Dist-Bankura on 19.07.2017 at about 12:10 P.M.

During inspection it was observed that Sri Shyamal Kabiraj was using Electricity unauthorisedly by means of direct hooking from nearest LTOH line of WBSEDCL for Domestic purpose of connected load 0.40 KW & disconnected the hooking wire with hooking arrangement and seized under a proper seizure list. After completion of inspection we left the spot at about 12:40 P.M. on that day.

Therefore, you are requested to take necessary action against Sri Shyamal Kabiraj for theft of energy U/S 135 (1)(a) of the electricity Act, 2003 and amended in 2007 and treat it as an FIR.
