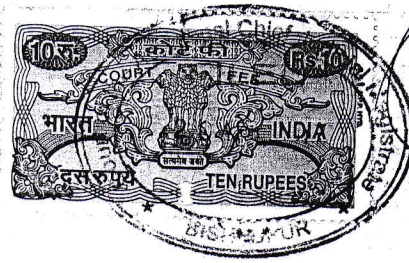

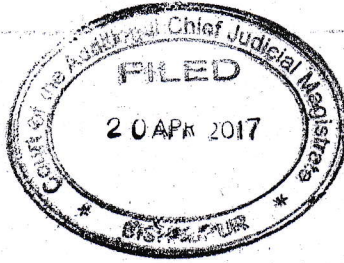
The humble petition of the Complainant

1. That the Complainant is the Director of the Annapurna Agro Plantec India PVT. LTD. ,
having its office at Vill- Senhati Colony. P.S- Bishnupur, Dist.- Bankura. And the said
accd. , Mr. Paritosh Pain S/O- Sisir Kr. Pain, Vill.- Beroya, P.O- Dauradanga, P.S-
Bhatar, Dist.- Burdwan, Pin Code- 713128, was one of the appointed "Area Sales
Supervisor" of the above said Company in terms of the agreement executed by him and
the authorised signatory of the Company at it's Bishnupur Office.
2. That the said accd. Was entrusted with the job for sales, marketing, and collection of
money towards price of goods sold by the company to it's purchasers against receipts
issued by him as well as to deposit the amount so collected by him at the Bishnupur
office of the said Company.

3. That accordingly the said accd. Mr. Pain had been collecting money from the purchasers of the company and going on depositing the same at the Bishnupur Office of the Company and inspite of the repeated cautions by the Company, he was found too much irregular in deposits though he used to collect money from the purchasers regularly.
4. That it appears from the account kept for him that Mr. Pain has not deposited the sum of Rupees Twelve Thousand Fifty Eight only [Rs.- 12,058/-] collected by him during the period from 2nd April, 2015 to 31st January 2017 and also irregularly kept some products of the company in his possession with a motive to grab the same, and inspite of our repeated reminders and demand notice and thus he has misused the money and the property of the company for his personal gain as wrongfull gain.
5. That the aforesaid willfull illegal acts of the said accd. Viz., Mr. Paritosh Pain, makes him liable and punishable under the penal provisions i.e., U/S- 403/406/409/420/506 IPC
6. That the Complainant informed the matter to the Bishnupur P.S. but till now the Bishnupur P.S has not take legal steps .

Your petitioner therefore prays Your Honour to issue process against the accused for offence committed under ss. 403/406/409/420/506 of the Indian Penal Code and to try and punish him in accordance with law . Complain file by petition U/S- 156(3) Cr.P.C, sayad to FIR Bishnupur Ps and started Case and investigation and Action.
