Motilal Rajwar, TSH, vi) Rajesh Majhi S/O-Lt. Dilip Kr. Majhi, TSH all of Chhatna C.C.C. WBSEDCL and (i) Sujeswar Sen S/O-Lt. Guruprosad Sen, SE(E), (ii) Singrai Tudu S/O-Lt. Thus it is evident that said Sunil Tudu S/O- Lt. Kalidas Tudu address Vill- Ramnathpur, P.O-Susunia, P.S-Chhatna, Dist-Bankura has committed theft of electricity and liable for prosecution of u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007. During inspection and checking in that said premises Sunil Tudu was not present there.

I prepared the inspection report on the spot and assessed the load which come to 0.15 KW. Local witnesses refused to sign in the inspection report.

I directed Sanatan Murmu, L.M. to de-hook the wire from nearby LTOH line of WBSEDCL. They de-hooked the hooking wire and I seized 01 (one) item of properties under proper seizure list.

The raiding party left the site at 17:40 Hrs. on same day (21.07.2017) after completion of inspection and checking.

You are therefore requested to please treat this written complain as FIR, start a case, arrest the accused and arrange investigation of this case.
