Sir,

I, MD Afroz Ahmad, Assistant Engineer & Station manager of Indpur CCC, PO+PS: Indpur, Dist: Bankura do hereby lodge a complaint against Dinabandhu Patra (User), S/O Lt. Satyakinkar Patra of Village+ PO: Araldihi, PS: Indpur, Dist.: Bankura, for committing theft of Electricity by Direct Hooking from nearest L.T.O.H. line at his commercial premises.

On today i.e. 17/07/2017 at about 16:50 hrs myself along with 1) Saroj Kumar Biswas (LM -Indpur CCC), 2) Surjeswar Sen (SE- S&LP Bankura Regional Office), 3) Anup Kumar Kar (SO- S&LP Bankura Regional Office), 4) Singuri Tudu (Sr. TSH- S&LP Bankura Regional Office) and others left for village Araldihi for holding raid following a source information.

We reached village Araldihi at 17:25 hrs and came to the commercial premises of Dinabandhu Patra (User), observed & found that Dinabandhu Patra (User) was enjoining electricity unauthorized by direct hooking from nearest LTOH line for commercial use in his premises and then the illegal line was disconnected by our technical staff as per my instruction.

I prepared the inspection report and seized the articles under proper seizure list. Dinabandhu Patra was not present when following item was seized. Local people was present but not appeared to sign.

We seized the articles (Sample basis) of single core PVC flexible cable of length about 50 meters with hooking arrangement. The seizure was made in between 17:30 hrs to 17:50 hrs. So Dinabandhu Patra (User) has committed theft of Electricity in his house by direct hooking from nearest LTOH line and liable for prosecution u/s 135(1) (a) of Electricity Act 2003, and with amendment Electricity Act 2007.

Kindly treat this Complaint as FIR and take necessary action.
