Ref: Lodging of a complaint against one Devdutta Guha residing at Vill & P.O.- Akul, P.S.-Indas, District- Bankura working as Assistant Professor of New Horizon Institution of Technology Phase -II, City Centre, South G.T, Road, Surja Sen Sarani, Durgapur, W.B. Pin-713208 under the Information Technology Act/The Scheduled castes and the Scheduled Tribes (Prevention of Atrocities) Act.

Sir,

I, Professor Shyamal Santra, MLA of Kotulpur Constituency and MOS Department of Panchayats & Rural Development & Public Health Engineering would like to address you as follows:-

1. That on 13.07.2017 one Devdutta Guha residing at Vill & P.O. Akul, P.S.-Indas, District Bankura and working as Assistant Professor of New Horizon Institute of Technology posted & shared some defamatory words against MLAs and MPs of the District of Bankura in facebook which is effecting the reputation of goodwill of us in the said post the said Devdutta Guha used insulting words which is very offensive.
2. That the posts as published in the facebook by Devdutta Guha indicates his intention to destroy the reputation of the MLAs and MPs of Bankura District. In the said post he says that 'Bankura District er MLA MP dara kichu hobe na'. Ora last bench er Students', Sob quotar Lok kichu hobe na, bises kore Indas'.
3. That the said Devdutta Guha is not aware of the fact that I have served as Assistant Teacher of Joypur High School and now engaged as a Professor at Bankura Saradmoni Mahila MahaVidhapith. This clearly shows that I am not a back bencher as posted by Devdutta Guha who has deliberately tried to destroy my reputation amongst the people at large.
4. That the posts made by Devdutta Guha depicts the MLAs & MPs of Bankura District as worthless persons and is of highly defamatory nature. That the said Devdutta Guha knowing fully well that these posts will cause public breach of peace as is facebook post is against the Democratically elected Ministers and Popular Leader of my Constituency which is highly condemnable. The said Devdutta Guha has also hurt me in an open forum by posting that I belong to a particular quota as such can do nothing. I belong to Scheldule Caste community and Devdutta Guha openly insulted me and my caste in a public forum. This Act if Devdutta Guha has intentionally insulted and humiliated me being a member of the Schedule Caste community in a place within public view. I think it also comes under the provision of Section 153A of Indian Penal Code wherein it is clearly stated that promoting enmity on ground of this type of things will is prejudicial to maintenance of harmony. It is also a veiled threat by Shri Guha to attempt to obstruct my duty as a public servant as per provisions under Section 152 of Indian Penal Code.




