This is to inform you that a Tathya Mitra Kendra at Rajagram PO-Rahagram having ID No.1901599560919292 (may be correct) is observed that the Electricity bills of the consumers which were paid at aforesaid Tathya Mitra Kendra had discrepancy in the receipts and also the bills amount which were paid by the consumers required to be paid immediately in the account of WBSEDCL instead of being holding it for long days. But the said Tathya Mitra Kendra holding the same amount due to which huge numbers of notice were generated due to non received of the appropriate electric charges within the schedule time at WBSEDCL end against the individual consumers who had already paid the electric bills at the said Tathya Mitra Kendra. Hence, the consumers come at our end and showed that they had already paid the amount at the Tathya Mitra Kendra at Rajagram.

This malpracticing is not only effect the revenue losses of WBSEDCL but also create bad impact on WBSEDCL. Therefore, it is requested to treat this letter against the Tathya Mitra Kendra at Rajagram as FIR.


It is also inform you that all the system of posting a bill you are maintain is effected in our revenue collection and ATC losses.
