at Joyrambati 33/11 KV sub-station
under Bishnupur Division

Sir,

In reference to the above subject matter this is
to inform you that at about 01:20 hrs on ~~20~~
20.07.2017 a huge mob reportedly from Deshra
village fed by 11 KV Tajpur feeder has gathered at
Joyrambati 33/11 KV sub-station under Bishnupur Division
and abused and heckled badly the On-duty operator
& Technical Support Hand & other maintenance
staffs present on spot and also compelled them
to give shut down of 11 KV Tajpur feeder for
almost 2 hours until a 100 KVA DTR in their
locality is energised. As a result power supply
is hampered at the Tajpur, Deshra and adjacent
area of Kotolpur Block. The On-duty operator
has communicated the stated incident at about
06:10 hrs on 20-07-2017 to the W/S, but due
to heavy breakdown of 11 KV & 33 KV feeders
and HT/LT bulk consumers as a result of
