Dear Sir,

I Sri Pradip Mandal (Age 41 years), S/o Sri Nalinikanta Mondal, A.E. & Station Manager of Barjora Customer Care Centre, WBSSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date to the effect do hereby lodging complaint against Sri Uday Sankar Mondal, S/o Magaram Mondal, Vill – Harekrishnapur, P.O- Dadhimukha, PS- Beliatore Dist- Bankura for committing theft of Electricity dishonestly in his house i.e. domestic premises which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

On getting information from secret source today on 24.07.2017 myself along with 1) Sri Sovan Das, S.A.E (E), Barjora CCC, 2) Sri Sanjay Lal Singh, Sr T.S.H, Barjora CCC, WBSSEDCL inspected the domestic Premises of Sri Uday Sankar Mondal, S/o Magaram Mondal, Vill – Harekrishnapur, P.O- Dadhimukha, PS- Beliatore Dist- Bankura at about 16.20 Hrs. During inspection it was detected that Sri Uday Sankar Mondal (42 years approx.) committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSSEDCL in his domestic premises.

I assessed the connected load as 0.6 KW and prepared the Inspection report accordingly.

I directed the technical staff to remove the hooking cable from LTOH line and accordingly the same was removed.

I seized the hooking cable by Seizure list at spot but the accused person and other local public refused to sign on seizure list. And we left the spot at about 16.40 Hrs on 24.07.2017.

The accused person has committed an offence under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are therefore requested to please treat this written complain as FIR, start a case, arrest the accused and arrange investigation of this case.
