Sub:- Prayer for lodging a case against the accd. namely Baul Mondal (38 yrs) s/o Lt. Bilash Mondal of vill- Patjore, PS Sonamukhi, Dist. Bankura for illegally manufacturing of Id liquor and stocking of Country Spirit.

Sir,

In producing herewith the arrested accd. namely Baul Mondal (38 yrs) s/o Lt. Bilash Mondal of vill- Patjore, PS Sonamukhi, Dist. Bankura and seized articles namely (1) one container containing 10 lts of Id liquor alongwith sample (2) 01 earthen pot in which a pipe is attached which is used for distillation (3) one piece of Aluminum Handi and (4) 20 nos. of sealed bottles of Country Spirit strength 60 up of brand "Captain" blended and bottled by IFB Agro Industries Ltd, Dharola, Panagarh Bazar, Burdwan each containing 600 ml, out of 20, 01 sealed bottle is taken as sample, all packed, sealed and labeled I ASI Buddhadev Mondal, presently posted to Sonamukhi PS, do hereby lodge a complaint against Baul Mondal (38 yrs) s/o Lt. Bilash Mondal of vill- Patjore, PS Sonamukhi, Dist. Bankura to the effect that on 21/07/17 at 16:45 hrs I received a secret information from my source that one Baul Mondal (38 yrs) s/o Lt. Bilash Mondal of vill- Patjore, PS Sonamukhi, Dist. Bankura is illegally manufacturing Id liquor and stocking Country Spirit adjacent to his house which is situated in vill.- Patjore. Accordingly I diarised the matter vide Sonamukhi PS GDE no. 878 dtd. 21/07/17 and myself alongwith force left PS to work out the information vide Sonamukhi PS GDE no. 879 dtd. 21/07/17 after sharing the information with my O/C. At about 17:25 hrs myself alongwith raiding party reached the spot as noted above and found that the above noted accd. person is engaged in manufacturing Id liquor in a shed attached to his house. We also noticed some sealed bottles of Country Spirit which were stocked in a corner of the shed. We in uniform introducing ourselves requested him to stop his activity of manufacturing of Id liquor and commanded him to produce valid document for carrying out such activity and stocking country spirit. He didn't pay heed to our words and continued his illegal activity as if nothing can stop him. We warned him several times but he kept his ears deaf. To prevent him from committing further offence I arrested him as per the procedure laid down in CrPC and followed the latest guidelines of the Apex Court and seized the above noted articles from his possession under proper seizure list in presence of Police as well as public witnesses. Though the public witnesses witnessed the seizure they denied to put their signature on seizure list as they feared assault by the accd. person due to his being dangerous and desperate in nature. I packed, sealed and labeled the seized articles at the spot. On local enquiry it

could be learnt that the said Baul Mondal manufacture Id liquor and stock Country Spirit adjacent to his house and supply the same to the adjacent villages without any legal authority. Local people also stated that he is continuing the above noted illegal activity since long and at some previous occasions he was caught red handed for which some cases relating to manufacturing and possessing of Id liquor etc., are pending against him in the Ld. Court. They warned him to stop such activity at several occasions but he didn't care to listen their words and continued his illegal business. As such Baul Mondal (38 yrs) s/o Lt. Bilash Mondal of vill- Patjore, PS Sonamukhi, Dist. Bankura is liable to be punished under proper section of law.

Therefore I pray that a necessary arrangement be made for recording a specific case against the aced. Baul Mondal (38 yrs) s/o Lt. Bilash Mondal of vill- Patjore, PS Sonamukhi, Dist. Bankura under proper section of law and for investigation of the same.
