I Sri Prasun Chowdhury, S/O- Pranesh Chowdhury, A.E & S.M Schooldanga CCC, WBSEDCL, P.S+Dist - Bankura, being empowered by the Electricity Act 2003 amended in 2007 do here by lodge complain against accused Sanjay Ray S/O Late Chitta Ray, of vill- Daripadanga, P.O.-Bankati, Dist+P.S- Bankura.

I have received an information that the accused person, Sanjay Ray S/O Late Chitta Ray, of vill- Daripadanga, P.O.-Bankati, Dist+P.S- Bankura was consuming electricity by direct hooking from nearby L.T.O.H. line. We have received information that the aforesaid accused person was consuming electricity in an unauthorized way by direct hooking from nearby L.T.O.H. line.

On getting this information on 21.08.2017 between 14.00 hrs to 14.45 hrs, I, along with Sri, Supriya Bhattacharjee, SAE (E) of Schooldanga CCC inspected the Domestic Premises of Sanjay Ray.

It was detected that the accused person has used a hooking cable for direct hooking purpose from nearby LTOH line and to commit the theft of Electricity.

I prepared the inspection report on the spot and the consumption of load was detected as 200w.

Under my direction the hooking cable was removed.

It is well evident that the accused person has committed an offence u/s 135 (1) (a) at the Electricity Act 2003 amended in 2007.

As such, kindly treat this as an F.I.R.
