I Sri Ajit Kumar Kundu, S/o Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatore Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Amar Ghosh , S/O of Lt Laxminarayan Ghosh of Vill-Barkura, P.O-Brindabanpur, PS- Beliatore Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today on 09.08.2017 at about 1.20 PM, I along with 1) Sri Subhadeep Roy, S.A.E (E) 2) Sri Alope Nath Karmakar, Hg Sr L.M 3) Abdul Kashem .L.M, 4) Gangadhar Mondal, L.M, 5) Yuddhapati Das, Hg TSH, 6) Satyapada Roy, Hg TSH 7) Sumanta Danguria, TSH all of them of Beliatore CCC inspected the domestic Premises of Sri Amar Ghosh of Vill-Barkura, P.O- Brindabanpur, PS- Beliatore Dist-Bankura.

During inspection it was detected that Sri Amar Ghosh committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use observed load 0.320kw. Inspection report was prepared at spot with signature of Purnima Ghosh, w/o Amar Ghosh.

I directed the Sri Alope Nath Karmakar, HG Sr L.M to remove the hooking cable from LTOH line. I seized some portion of the hooking cable & prepare seizure list at spot

It is well proved that the accused Amar Ghosh is liable for prosecution as committed theft of electricity under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
