On getting information today 19.08.2017 at about 12.40 PM,I along with 1) Sri Subhadeep Roy, S.A.E (E) 2) Sri Aloke Nath Karmakar, Hg Sr L.M 3) Abdul Kashem ,L.M, all of them of Beliatore CCC and Sri Rajesh Kundu, D.E (Tech) of Bankura (D) Division, WBSEDCL inspected the domestic Primises of Sri Budhan Tung (user) of Vill- Salbani, P.O- Brindabanpur, PS- Beliatore Dist- Bankura.

During inspection it was detected that Sri Budhan Tung (user) committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 200131434 by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use as a result the energy consumption was not recorded. Observed load 0.24kw (4 nos CFL, 1 nos 100 watt bulb, 1 nos fan) Inspection report was prepared at spot with the signature of accused Sri Budhan Tung. Local people was asked for their signature but they refused.

I directed the technical staff to remove the hooking cable from LTOH line and also disconnect the existing permanent service line bearing consumer ID 200131434.

I seized some portion hooking cable and one nos 100 watt lamp and prepare seizure list at spot. we left the spot

It is well proved that the accused Budhan Tung (user) is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.
