Sir,

I, Sri Sukomal Kanti Das, SDPO Bishnupur, do here by produce a. Dilip Ghugu(40yrs), so: Proboddh Ghugu of Majuria b. Bapi Mandal(30yrs), so: Padmalochan Mandal of Majuria and c. Janardan Pal (42yrs), so: Gouri Shankar Pal of Borokalitola (Ward 17) – all under P.S. Bishnupur, Dist. Bankura and seized articles viz. 15 and 16 bottles of country spirits (maker CAPTAIN and each containing 600ml of liquor), 04 empty glasses having alcoholic smell and 03 bottles of country spirits (maker CAPTAIN and filled half to the capacity) and do hereby lodge a complaint as suo-motto that today on 14.08.17 in between 15:35hrs and 17:05hrs, (vide Bishnupur P.S. GDE No. 620, dt..14.08.17), myself along with officers and forces of EF Line Bishnupur had been holding special drive against criminals, antisocial within Bishnupur P.S. jurisdiction.

At 16:05hrs, on arrival in front of "Baba Lokenath Hindu Hotel" at Morar 01 No, aforesaid 03 persons were selling alcoholic drinks of above description to 03/04 clients. On seeing us, the clients fled away; but aforesaid 03 were detained and on examination, they disclosed that inside two corners of hotel, said 15 and 16 bottles of country spirit were stored for sale.

They admitted that despite not having the license of the excise department, they are selling country spirit to clients, converting the hotel into a makeshift bar. Accordingly, I searched and found 31 bottles of country spirits inside two corners of said hotel. Seized those ones accordingly under the memo of seizure from 16:10hrs to 16:30hrs duly attested by public and Police witnesses along with the aforesaid 04 number of empty glasses and 03 bottles of country spirits of CAPTAIN company and filled half to the capacity. All 31 bottles were sealed and labeled by Govt. of West Bengal.

The act of the aforesaid persons is liable u/s: 46A BE Act. Hence, a case may be started against aforesaid 03 accd. persons u/s: 46A BE Act.
