I, Joydeep Halder S/O Bimal Chandra Halder, A.E & Station Manager, Bishnupur Customer Care Centre, WBSEDCL being empowered by Electricity ACT 2003 amended in 2007 do hereby lodge a complaint against accused Ashim Roy S/O Late Shibapada Roy Village- Morar 2 No. Camp, Sumangalam Home Quarter P.O - Morar, P.S-Bishnupur to the effect that received an information that the said accused person is committing theft of electricity by Direct Hooking from nearby LT Over Head Line of W.B.S.E.D.C.L for the purpose of enlightenment of their House and fulfill their day to day need.

On getting the information of theft of electricity I along with Suprakash Layek , S.A.E , S/O Prabhat Kumar Layek ,Sk. Samsul Alam S/O Late Najrul Alam and other technical staffs of Bishnupur CCC Office on dated 23/08/2017 between 12:00 to 12:30 hours inspected the premises(Govt Quarter) of Ashim Roy S/O Late Shibapada Roy at village: Morar 2 No. Camp Sumangalam Home P.O: Morar P.S : Bishnupur Dist : Bnakura.

During inspection it was detected that the said accused person were committing theft of electricity by direct hooking from nearby LT Over Head Line of W.B.S.E.D.C.L by a yellow, black coloured single core PVC Cable approximate length 8 meter for the purpose of enlightenment of their House and fulfill their day to day need. It was found that connected load was 1 Nos. of 100 watt incandescent bulb and 1 Number fan 80 watt . 1 number Refrigerator 300 watt, Computer 1 number 300 watt.

I prepared inspection report on the spot and assessed consumption of load which was detected as 780 Watt. The details I have mentioned in inspection report.

I directed Sk Samsul Alam, TSH s/o Lt. Najrul Alam to remove the Hooking Cable which was connected to LT over head line of WBSEDCL. Accordingly he De- hooked the cable and I seized the same and prepared the seizure list.

Copy of seizure list and inspection report couldn't be supplied to the accused person or his representatives as they are not present at the spot. It is well proved that accused Ashim Roy S/O : Late Shibapada Roy village: Morar 2 No. Camp Sumangalam Home Quarter P.O: Morar P.S: Bishnupur Dist: Bankura was involved in the case of theft of electricity.

Please lodge the complaint as F.I.R.
