
Sir,

I Sukamal Kanti Das, Sub-Divisional Police Officer, Bishnupur under District - Bankura do here by produce the following arrested accused - 1. Danu Ray S/O - Madan Ray of Churamonipur, PS - Bishnupur. 2. Satyanarayan Garai S/O - Lt. Sudhir Ch. Garai of Gopalpur, PS - Do both under district Bankura with following seized items - a) Raw Coal weighing 25/30 Tonnes approximately. b) 08 Pcs of White Polythene sheets each having length of 25/30 ft which had been used to cover the bamboo fencing which was used as a hidden den for the business of stolen coal. c) 06 Pcs of spades having stain of coal. d) 20 Pcs of plastic buckets used for carrying coal. e) 06 Pcs of head guards made of plastic locally known as "Beri" and do here by lodge a complaint against said two arrested persons and their two associates namely 1) Saheb @ Avisek Ghosh of Chak Bajar 2) Bappa Rakhsit of Madhabganj, both of Bishnupur PS. 3) Provat Nandy of Bakadaha PS Bishnupur and unknown truck owners and drivers who supplied the stolen coals and carried the sold out stolen coal to and from aforesaid accused, as suo motu to the effect that on 27.08.2017 at 16.55 Hrs received an information from source that aforesaid two arrested accused and with said Saheb @ Avisek Ghosh and Bappa Rakhsit are procuring stolen coal from unknown trucks at one open ground at Churamonipur, PS - Bishnupur belonging to one Prabhat Nandi of Bakadaha, PS - Bishnupur, said open ground has been enclosed with bamboo fencing covered with said polythene sheet and unknown labours have been engaged to unload the stolen coal from said unknown trucks, accordingly noted the information of source vide Bishnupur PS GDE No: 1316 Date: 27.08.2017 & Myself with SI Biswanath Das and force left for aforesaid place at Churamonipur, PS - Bishnupur with source vide CC No: 4417 date: 27.08.2017. At 17.20 hrs reached at Churamonipur ground as above with officer, men and source. At seeing us aforesaid four named accused tried to flee away but we managed to grab aforesaid Danu Roy and Satyanarayan but remaining two named accd managed to escape and found the truck from which the accds allegedly procuring stolen coal has already disappeared. The labourers those who were engaged to unload the stolen coal from the disappeared truck had fled leaving said 25/30 Tonnes of raw coal on the ground, aforesaid plastic buckets, spades, and head guards. On being asked aforesaid Danu and Satyanarayan disclosed their names as above and admitted that they in association with said Avisek and Bappa have been running the business of stolen coal procured from said unknown trucks laden with said stolen coal and they used to sell it local customers ranging from brick field owners to industrialists at the wrongful loss of state and wrongful gain of themselves and also added that said Provat Nandy despite knowing the illegal nature of business of stolen coal left the ground on hire in lieu of Rs 10000/- per month. Both of them failed to produce valid documents on the strength of which the coal was procured and subsequently possessed. So I have reason to believe that said coal were stolen or fraudulently obtained and the accused habitually deal in it. So I seized those items under a memo of seizure duly attested by the witnesses and said two arrested accused from 17.40 hrs to 18.00 hrs, made over a copy of seizure list to the accused. From 18.20 hrs to 18.40 arrested both the accds namely Danu Ray and Satyanarayan Garai after issuing memo of arrest as they along with Avisek, Bappa Rakhsit, Provat Nandy and unknown truck owners/drivers are liable for receiving stolen coal, disposing it as habitual offenders. Conveyed the ground of arrest and observed other procedure of arrest laid down by Hon'ble apex court.

Made over the seized coal to IC PS. Hence I request you to lodge an FIR u/s 411/413/414/34 IPC against said arrested Danu Ray, Satyanarayan Garai, Avisek Ghosh, Bappa Rakhsit, Provat Nandy and unknown truck owners and drivers.


