I, Anup Kumar Mandal S/O-Sri Sahadeb Mandal, Station Manager, Chhatna C.C.C, WBSEDCL being authorized under the electricity Act'2003 and electricity (Amendment) Act'2007 do here by lodge complaint against Avi Bauri (user) S/O-Lt. Promotha Bauri address Vill-Laxmisole, P.O-Baidya Laxmisole, P.S-Chhatna, Dist-Bankura for theft of electricity u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007 as stated here under;-

That on 21/08/2017 in between from 12:20 Hrs. to 12:50 Hrs. myself along with (i) Soumen Mondal S/O-Sri Meghnath Mondal, SAE(E), (ii) Sanatan Murmu S/O-Lt. Mansaram Murmu, L.M., (iii) Md. Selim Khan S/O-Lt. Sayed Khan, Gr.-1 TSH, (iii) Shaktipada Mahato S/O-Lt. Santosh Mahato, TSH all of Chhatna C.C.C. WBSEDCL and (i)Anup Kr. Kar, S.O. (S&LP), (ii) Singrai Tudu S/O-Lt. Sonaram Tudu, Sr. TSH all of S&LP unit Office Bankura inspected the domestic premises of Avi Bauri as noted above and found that he was using electricity unauthorizedly and dishonestly by direct hooking from nearby LT mains of WBSEDCL by means of hooking device for their domestic use.

Thus it is evident that said Avi Bauri S/O- Lt. Promotha Bauri address Vill-Laxmisole, P.O-Baidya Laxmisole, P.S-Chhatna, Dist-Bankura has committed theft of electricity and liable for prosecution of u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007. During inspection and checking in that said premises Avi Bauri was not present there.
