That on 21/08/2017 in between from 14:45 Hrs. to 15:15 Hrs. myself along with (i) Soumen Mondal S/O-Sri Meghnath Mondal, SAE(E), (ii)) Sanatan Murmu S/O-Lt. Mansaram Murmu, L.M., (iii) Md. Selim Khan S/O-Lt. Sayed Khan, Gr.-1 TSH, (iii) Shaktipada Mahato S/O-Lt. Santosh Mahato, TSH all of Chhatna C.C.C. WBSEDCL and (i)Anup Kr. Kar, S.O. (S&LP), (ii) Singrai Tudu S/O-Lt.
