I, Sandip Das S/O-Lt. Bhabesh Chandra Das, Station Manager Mejia C.C.C, WBSEDCL being authorized under the electricity Act,2003 and electricity (Amendment) Act,2007 do here by lodge complaint against Sri Shaktipada Ghosh S/O- Lt. Khudiram Ghosh. Address: Palajhuria Company Para Vill- Palajhuria, P.O- Ranipur, P.S-Gangajal Ghanty, Dist-Bankura for theft of electricity u/s- 135(1)(a) of the electricity Act,2003 and electricity (Amendment) Act,2007 as stated here under ;-

Information revealed that the aforesaid person using electricity by theft by hooking from nearby LTOH Line of WBSEDCL for Domestic use in his house located at village Palajhuria, P.O- Ranipur, P.S-Gangajal Ghanty, Dist-Bankura .

That on dated 21.08.2017 in between 13:00 Hrs. and 13:30 Hrs. myself along with (i) Kanai Kundu (SAE Mejia CCC), S/o Nimai Kundu (ii) Monoj Biswakarma (Sr Assistant), Mejia CCC S/o Lt. Mathur Biswakarma (iii) Dipak Kumar Sharma (ACM, Mejia CCC) S/o Lt Sudarshan Sharma and others inspected the domestic premises of premises of Sri Shaktipada Ghosh S/O- Lt. Khudiram Ghosh. Address: Palajhuria Company Para Vill- Palajhuria, P.O- Ranipur, P.S-Gangajal Ghanty, Dist-Bankura as noted above and found that he was using electricity unauthorisedly and dishonestly by direct hooking from nearby LT mains of WBSEDCL.

During inspection and checking Sri Shaktipada Ghosh S/O- Lt. Khudiram Ghosh. Address: Palajhuria Company Para Vill- Palajhuria, P.O- Ranipur, P.S-Gangajal Ghanty, Dist-Bankura, was present in his Premises. Thus it is evident that said Sri Shaktipada Ghosh S/O- Lt. Khudiram Ghosh. Address: Palajhuria Company Para Vill- Palajhuria, P.O- Ranipur, P.S-Gangajal Ghanty, Dist-Bankura has committed theft of electricity by direct hooking with LTOH Line of WBSEDCL and liable for prosecution u/s 135(1)(a) of the electricity Act,2003 and Electricity Amended in 2007.

I prepared the inspection report and assessed the load which came to 0.5 KW on the spot.

The hooking line was disconnected as per provision of law & I seized the same preparing seizer list.

Local witnesses refused to sign on the inspection report and seizure list none appeared as representative also. There were other items of electrical appliances which could not be removed and sized at the time of raid. The raiding party left the site at 13.45 Hrs. on same day (21/08/2017) after completion of inspection and checking.

You are therefore requested to please treat this written complain as FIR, Start a case under section 135 (i) (a) of Electricity Act 2003 amended in 2007 arrest the accused and arrange investigation of this case.
