Sir,

I, Sri Paritosh Kumar Baidya S/O- Lt. Amulya Kumar Baidya, Station Manager Hirbandh C.C.C, WBSEDCL being authorized under the electricity Act,2003 and electricity (Amendment) Act,2007 do here by lodge complaint against Khokan Bauri S/O. Lt. Kamal Bauri address, Vill- Benchaboni, P.O- Baidyanathpur, P.S- Hirbandh, Dist-Bankura for theft of electricity u/s- 135(1)(a) of the electricity Act,2003 and electricity (Amendment) Act,2007 as stated here under :-

That on 18.08.2017 in between 13:00 Hrs. and 13:15 Hrs. myself along with (1) Subodh Chandra Patra (Hg Sr. L.M.) S/O- Lt. Nirmal Chandra Patra (2) Mathur Chandra Gope (Sr. T.S.H) S/O- Lt Budheswar Gope (3) Shibsankar Chakraborty (T.S.H.) S/O- Lt. Joydeb Chakraborty and others inspected the premises of Khokan Bauri with address as noted above on the basis of secret source information.

During inspection and checking Khokan Bauri was using electricity unauthorized and dishonestly by direct hooking from nearby LT mains of WBSEDCL for domestic purpose causing huge revenue loss to WBSEDCL. During inspection said Khokan Bauri was present on the spot and refuses to sign on the seizure list and inspection report also.


Thus it is evident that said Khokan Bauri S/O. Lt. Kamal Bauri address, Vill- Benchaboni, P.O- Baidyanathpur, P.S- Hirbandh, Dist-Bankura has committed theft of electricity by direct hooking nearby LT mains of WBSEDCL and liable for prosecution u/s 135(1)(a) of the electricity Act,2003 and Electricity Amended Act 2007.

I prepared the inspection report and assessed the load which came to 0.3 KW on the spot.  
The Service line was disconnected as per provision of law & I seized the same by preparing seizer list.  
Local witnesses refused to sign on the inspection report and seizure list.

There were other items of electrical appliances which could not be removed and sized at the time of raid. The raiding party left the site at 13:16 Hrs. on same day (18.08.2017) after completion of inspection and checking.  
It is also mentioned here that Khokan Bauri S/O. Lt. Kamal Bauri address, Vill- Benchaboni, P.O- Baidyanathpur, P.S- Hirbandh, Dist-Bankura made no complain for ill treatment.

So, you are requested to treat this written complain as FIR, Start a case, arrest the accused and arrange investigation.


