Sir,
 I, Sri Paritosh Kumar Baidya S/O-Lt.Amulya Kumar Baidya, Station Manager Hirbandh C.C.C, WBSEDCL being authorized under the electricity Act,2003 and electricity (Amendment) Act,2007 do here by lodge complaint against Bipul Mahanta S/O. Lt. Bhabataran Mahanta address, Vill- Arjunda, P.O- Bauridiha, P.S- Hirbandh, Dist-Bankura for theft of electricity u/s- 135(1)(a) of the electricity Act,2003 and electricity (Amendment) Act,2007 as stated here under :-
 That on 08.08.2017 in between 14:10 Hrs. and 14:30 Hrs. myself along with (1)Anup Kr Kar (S.O, S & LP), Bankura Region, WBSEDCL, S/O- Lt. Amiya Kar (2) Srijib Sinha (L.M.) Hirbandh CCC S/o Lt Radheshyam Sinha (3) Mathur Chandra Gope (Sr. T.S.H) S/O- Lt Budheswar Gope (4) Ashis Mahato (T.S.H.) S/O- Kshudiram Mahato and others inspected the premises of Bipul Mahanta, with address as noted above on the basis of secret source information
 During inspection and checking Bipul Mahanta was using electricity unauthorized and dishonestly by direct hooking from nearby LT mains of WBSEDCL for domestic purpose causing and there by huge revenue loss to WBSEDCL. During inspection said Bipul Mahanta was present on the spot and refuse to signed on the seizer list and inspection report also.
 Thus it is evident that said Bipul Mahanta S/O. Lt. Bhabataran Mahanta address, Vill- Arjunda, P.O- Bauridiha, P.S- Hirbandh, Dist-Bankura has committed theft of electricity by direct hooking nearby LT mains of WBSEDCL and liable for prosecution u/s 135(1)(a) of the electricity Act,2003 and Electricity Amended Act 2007.

I prepared the inspection report and assessed the load which came to 0.3 KW on the spot.
 The Service line was disconnected as per provision of law & I seized the same by preparing seizer list.
 Local witnesses refused to sign on the inspection report and seizure list.
 There were other items of electrical appliances which could not be removed and sized at the time of raid. The raiding party left the site at 14.31 Hrs. on same day (08.08.2017) after completion of inspection and checking
 It is also mentioned here that Bipul Mahanta S/O. Lt. Bhabataran Mahanta address, Vill- Arjunda, P.O- Bauridiha, P.S- Hirbandh, Dist-Bankura made no complain for ill treatment.

So, you are requested to treat this written complain as FIR, Start a case, arrest the accused and arrange investigation.
