Sir,

In producing here with the accused namely 1) Subash Kundu @ Laxman S/O Lt dharmdas Kundu of vill- Thakuranipuskarani PS- Indas Dist - Bankura with seized ID liquor amounting about 10 bottle C.S styled "Tarzan" and I beg to submit that today (17.08.17) while myself along with force were engaged in evening patrolling duty in PS area. At about 19:15 hrs received a secret source information that some person selling ID liquor at Gobindapur more in an open place. Acting on secret source information I informed to O/C Indas PS over telephone and as per his direction I along with force had been to Gobindapur more and found some person assembled in the side of main road of Gobindapur more. I along with force held raid and able to apprehend 01 person noted above, many of them succeed to flee away from the spot. On being search found 10 bottles of colorless liquid country spirit. On being asked he did not produce any document in respect of selling of country spirit. over this circumstances it was clear that the above accused person was selling country spirit to the persons & stocking liquors with a view to wrongful gain by losing huge revenue of the Govt. Accordingly I seized the following bottles with country spirit from exclusive control of the custody of the accused person as noted above under proper seizure list duly label and signed by the witnesses. So that he is liable to be prosecuted U/S 46A(c) of B.E Act. As he was found selling liquors openly and caught red handed, So I arrested him by maintaining all the formalities, and issued arrest memo informing ground of arrest and to maintain U/S 50 Cr pc after that producing this PS .


Seized articles:
