station manager khatra customer care centre, WBSEDCL being empowered
by electricity act 2003 amended in 2007 do here lodge complaint against
Kangal Das, son of late Gobinda Das vill- Mingipahari, P.O- Supur, P.S-
Khatra, Dist- Bankura, 135(1)(a) of the electricity act 2003 amended in 2007 to
effect that received an information that Kangal Das is committing theft
of electricity by direct hooking from LTOH line of WBSEDCL purpose of
running his poultry farm.

In getting that information of the theft of electricity today on
1.08.2017 12:30 PM to 12:45 PM along with Sri Kingshuk Bose (SAE), Sri
Harendra Nath Mahata (TSH), Md. Rabbul (TSH), Shishir Kumar Mishra (TSH),
attached to Khatra CEC, WBSEDCL inspected the premises of Kangal
Das and nearby LTOH Line.

During inspection it was detected that above said person has been committing
theft of electricity by direct hooking from nearby LTOH line of WBSEDCL
for the purpose of running his poultry farm. The hooking cable (2 core) was
found and connected to LTOH line of WBSEDCL.

Prepare inspection report on the spot assessed the consumption of
load as 0.4 KW.

Directed Sri Harendra Nath Mahata TSH, to dehook the hooking cable
and accordingly he has dehooked the cable, which have been seized.
It is well evident that Kangal Das has been committing theft of electricity
by direct hooking from nearby LTOH line of WBSEDCL. As such he
is liable for prosecution U/s 135(1)(a) of electricity act 2003
amended on 2007.
