I Abhishek Rai S/O- Sri Vijay Prakash Rai, AE & Station Manager of the Patrasayer Customer Care Centre "WBSEDCL being authorized under the Electricity Act.-2003 and Electricity (Amendment) Act-2007, do hereby lodge complaint user accused Sk Nijam S/O Sk Abdul Rezzak viLL-Dullalpur PO-Hamirpur P.S- PatrasayerDist-Bankura for theft of electricity by direct hooking with the help of hooking cable from nearby L.T. O.H line of WBSEDCL, U/S.- 135(i) (a) of Electricity Act 2003 and electricity (Amendment) Act-2007, as Stated here under

That on 4.08.2017 in between 3:30p.m. and 3:55 p.m Myself along with Nepal Chakraborty (HG LM) of Patrasayer CCC and Surjeswar Sen, S.E(S&LP) Anup Kumar Kar, S.O(S&LP), R.O Bankura and others on the basis of secret source information inspected the Domestic premises of user accused Sk Nijam S/O Sk Abdul Rezzak viLL-Dullalpur PO-Hamirpur PS-Patrasayer, Dist-Bankura and during inspection it was found that user accused Sk Nijam was using electricity unauthorizely and dishonestly in his Domestic premises by direct hooking from nearest LT mains of WBSEDCL with the help of Two nos single core PVC cable found one end in bend condition to use as hooking device. .So, he has committed theft of electricity and liable for prosecution U/S.-135(i) (a) of electricity Act-2003 and electricity (Amendment) Act-2007.

I prepared the inspection report on the spot and assessed the load which comes to 0.7KW.I directed Nepal Chakraborty to dehook the hooking cable fitted with LTOH line of WBSEDCL . He accordingly dehooked the same and I seized the same preparing seizure list. Copy of seizure list and inspection report could not handed over to the accused person neither his representative refused to accept that.

The inspection team left the site at 4:05 p.m hrs on 04.08.2017 after completion of inspection & Raid. It is well proved that user accused Sk Nijam S/O Sk Abdul Rezzak viLL-Dullalpur PO-Hamirpur viLL-Dullalpur P.S- Patrasayer, Dist- Bankura committed theft of electricity by direct hooking from nearby LTOH line of WBSEDCL as such he is liable for prosecution u/s 135 (1)(a) of Electricity Act 2003 amended in 2007.

So you are requested to treat this complaint as F.I.R.
