Sir,

I Sri Kuntal Manna, S/O- Sri Sasanka Sekher Manna , Station Manager of the Ranibandh Customer Care Centre being authorized under the electricity Act.-2003 and electricity (Amendment) Act-2007, do here by lodge complaint against Sri Goutam Goswami , S/O- Lt. Barid Baran Goswami of Vill & P.O- Ambikanagar, P.S- Ranibandh, Dist- Bankura for theft of electricity by direct hooking with the help of hooking device from nearby L.T. mains of WBSEDCL, U/S.- 135(i) (a) of electricity Act 2003 and electricity (Amendment) Act-2007, as Stated here under.

That on 11/08/2017 in between 14:50 Hrs. and 15:10 Hrs. myself along with (i) Sri Somnath Soren, S/O- Pannalal Soren, S.A.E.(E), Ranibandh C.C.C (ii) Sri Sanjit Mahato, S/O – Rampada Mahato, T.S.H., Ranibandh C.C.C and others on the basis secret source information inspected the building of Sri Goutam Goswami , S/O- Lt. Barid Baran Goswami of Vill & P.O- Ambikanagar, P.S- Ranibandh, Dist- Bankura and found that said Sri Goutam Goswami was using electricity unauthorizely and dishonestly in his building by running T.V., light and other at Ambikanagar, P.S.- Ranibandh, under Ranibandh CCC ,Dist- Bankura by direct hooking from nearest LT mains of WBSEDCL with the help of hooking device. Causing huge loss of revenue of WBSEDCL . So, he has committed theft of electricity and liable for prosecution U/S.-135(i)(a) of electricity Act-2003 and electricity (Amendment) Act-2007.

I prepared the inspection report and assessed the load which comes to 0.6 K.W. The unauthorized line was disconnected as per rule of WBSEDCL with the help of technical staff.

I seized one item of property under proper seizure list duly signed by the witness .At time of inspection said Sri Goutam Goswami or his representative were not present at the site. So, I could not take their signature on the inspection report and seizure list .Local villagers refused to put their signature on the seizure list.

There were other items of electrical appliances like T.V., Light etc. which could not be removed and seized.

The inspection team left the site at 15:11 hours on 11/08/2017. So you are requested to treat this written complaint as F.I.R, start a case, arrest the accused and arrange investigation.
