I, Sri Biswadeb Biswas S/O- Dr. Buddhadeb Biswas, A.E. & S.M., Saltora C.C.C., WBSEDCL being authorized under the electricity Act'2003 and electricity (Amendment) Act'2007 do hereby lodge complaint against AshokeMallick (user) (consumer id: 232042785) address Vill- Shirpura, P.O-Bamuntore, P.S- Saltora, Dist-Bankura for theft of electricity u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007 as stated here under:-

That on 11.08.2017 in between from 13:00 Hrs. to 13:20 Hrs. myself along with (i) Srideb Saha S/O- Sri Sidam Saha, SAE(E), (ii) Sushanta Paramanik S/O- Sri Dharendra Nath Paramanik, O.E., (iii) Debabrata Ganguly S/O- Ramanuj Ganguly, Technical staff outsourced all of Saltora C.C.C. WBSEDCL and (i) Sujeswar Sen S/O- Lt. Guruprosad Sen, SE(E), (ii) Singrai Tudu S/O- Lt. Sonaram Tudu, Sr. TSH all of S&LP unit of RM Office Bankura inspected the domestic premises of Ashoke Mallick as noted above and found that he was using electricity unauthorizedly and dishonestly by direct hooking from nearby LT mains of WBSEDCL by means of hooking device for their domestic use.

Thus it is evident that said Ashoke Mallick (Consumer Id: 232042785 deemed) address Vill- Shirpura, P.O-Bamuntore, P.S- Saltora, Dist-Bankura has committed theft of electricity and liable for prosecution of u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007. During inspection and checking in that said premises Ashoke Mallick was not present there.
