Sub:- Prayer for lodging specific case against 1) Laltu Bhandari (20yrs) s/o Purna Chandra Bhandari 2) Bikash Mondal (26yrs) s/o- Prodip Mondal. 3) Madhai Bouri (21yrs) s/o- Lt. Poran Bourir all of Vill-Jamgram, P.S. Baraboni, Dist-West Burdwan

In producing herewith the arrested accds namely i) Laltu Bhandari s/o Purna Chandra Bhandari 2) Bikash Mondal s/o- Prodip Mondal. 3) Madhai Bouri s/o- Lt. Poran Sir, Bourir all of Vill Jamgram P.S. Baraboni, Dist-West Burdwan, along with memo of Arrest, including seized articles under proper seizure list,- 1) Two pcs of dagger, 2) one improvised fire arms having length Barrel 5" approx, body 2" approx and wooden butt 3" approx, fitted with one pc live cartridge, 3)one White colour ambasater car bearing Regi no-WB38AG/9557 4)one iron rod 5) one old bicycle chain 6)one plastic Torch light, followed by labels dully signed by police witnesses, it is to note that today (24.08.17) at 22.25 hrs received a secret source information that some 10/15 accused persons have been assembled near Jaina Mandir under Gogra GP on Lakhanpur village to chattana road, with preparation to commit any dacoity or anything heinous crime. Accordingly I conveyed the information to O/C Saltora PS and as per his direction myself along with available constables left for persue the information after taking all informative actions being noted in G.D vide Saltora PS. G.D E. No 856/17, dtd. 24/08/17. Myself alongwith force, vide Saltora PS C.C. No- 1580/17, Dt-24.08.2017 and with Govt vehicle no- WB68D/0005, left for proper identification of the spot as guided by my source. Accordingly at about 23.40 hrs we reached at Lakhanpur village near jaina mander at Lakhanpur village, and left the govt. vehicle in a safe distance, then proceeded towards the place of assembly of the miscreants led by source. We the police party cordoned the entire area. Seeing the Police party they all started to take to their heels but after a hot chase they have been restrained and disclosed their names and addresses as noted above but few others managed to escape from the spot. Be it noted that before chasing it was found that they were talking in between themselves in a very hasty voice and after apprehending followed by on interrogation in a slip sort manner they have confessed their guilt and admitted that they have formed a criminal gang for committing house dacoity and for such they have assembled there and making preparation for committing house dacoity in the houses of some local businessman. (contd...)

As well as they also disclosed that the accds who fled away from the spot are well known to them and they are having sound noxious relationship with them as they have formed a sound criminal gang for committing house dacoity at local area. Accordingly search and seizure have been made in presence of the police witnesses as no public witness found in the dead hour of night.

As their offence comes under the purview of section 399/402 IPC & 25/27 Arms act, I arrested them under memo of arrest being observed all the formalities in compliance to the directions of the Hon'ble Apex Court of India and NHRC/WBHRC, hence it is prayed to start a specific case under section 399/402 IPC & 25/27 Arms Act against the above noted accds and to arrange for its investigation.
