Mem, I was married to Ramratan Karmakar in the year 1994 and  
we have two sons.

Since beginning he had the habit of quarrelling, abusing and  
fighting. On many occasions, he abused and hit me. Last night  
(02/08/17) at around 09:00 pm. he started quarrelling with me  
and trying to hit me also. He kept abusing me and my sons continuously  
and threatened to kill us also. At around 09:30 pm. He was  
again trying to hit me and when my younger son Rohit tried to save  
me from him, he threw a tile which hit my son Rohit and he was badly  
injured. He had to go to the hospital for urgent treatment. Throughout  
the night we could not sleep in fear. He started torturing me  
physically immediately after the marriage and increasing day by day.  
I, therefore, request your good-self to kindly take immediate  
action in this regard so that cannot harm any copy of the hospital


