In producing here with the following seized 01(one) bottle of Royal Challenge Whisky containing 750 ml , 02(Two) Blenders Pride whisky containing 750 ml each , 02 (two) bottles of Mc Dowell whisky containing 750 ml each , 02 (two) bottles of Imperial Blue whisky containing 750 ml each , 02 (two) bottles of Royal Stag whisky containing 750 ml each , 06 (two) bottles of Officer Choice whisky containing 750 ml each , 03 (Three) bottles of Mc Dowell Rum containing  $\,750\,$  ml each  $\,$  , one  $\,01\,$  bottle of Blenders pride Whisky containing  $\,375\,$  ml  $\,$  ,  $\,02\,$ bottles of Royal stag Whisky containing 375 ml each , 02 bottle of officer choice Whisky containing 180 ml each 15 bottles of Tuborg Beer containing 750 ml each , I do hereby lodge this written complaint to the effect that as per tip off sources information and as per your order today on 04.09.17 (GDE reference.- 184) in between 18.50 hrs to 19.25 hrs I SI Prodipta Paitandi accompanied ASI Nabin Shit and along with force held raid in Swapnil Hotel situated at Bishnupur Bypass, and during search from one room of the hotel we found the above noted liquors stocked in a room . During local enquiry it is learnt that the co owner of the said Hotel namely Sanjay Mukherjee s/o Samir Mukherjee of vill.- Gabdoba , PS.- Bishnupur , Bankura stocked the liquors with a intension to sell them to the local customers for earning easy money . During further enquiry it is revealed that he used to run this business since one and half year. Hence I seized those bottles of liquor noted above under proper seizure list , duly signed by the witnesses and made proper Labeling of the same along with sample. But as all the staff of the said hotel fled away for avoiding police arrest the apprehension of any person engaged in this business could not be achieved.

Hence I am requesting that One FIR may kindly be drawn up against the above noted accd person U/S 46 (a) BE Act.
