On getting information today on 06.09.2017 at about 12:50 PM, I along with 1) Sri Subhadeep Roy, S.A.E (E) 2) Abdul Kashem ,L.M. 3) Gangadhar Mondal, L.M. 4) Yuddhapati Das, Hg TSH, 5) Satyapada Roy, Hg TSH 6) Sumanta Danguria, TSH all of them of Beliatore CCC inspected the domestic Premises of Sri Samir Chakraborty of Vill-Beliatore (mondalpara), P.O- Beliatore, PS- Beliatore Dist- Bankura. During inspection it was detected that Sri Samir Chakraborty committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use & observed load 0.22 kw.(2 nos

Inspection report was prepared at spot and local people and representative of accused were asked for signature but they refused.

I directed the Sri Abdul Kashem, L.M to remove the hooking cable from LTOH line.

I seized some portion of the hooking cable & prepare seizure list at spot

It is well proved that the accused Samir Chakraborty, S/o Niranjan Chakraborty is liable for prosecution as committed theft of electricity under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.
