I Bikash Kumar Dalal S/o LT Pravakar Dalal, A.E & S.M Lalbazar CCC, W.B.S.E.D.C.L being empowered by electricity act of 2003 amended in 2007 do hereby lodge complaint against accused Chiranjit Chowdhary (User), S/o LT Biswapati Chowdhary, Vill-Bhadul, P.S & Dist Bankura to the effect that receiving an information the aforesaid accused person is committing theft of electricity by bypassing the energy meter with tapping the existing service cable of consumer ID 232019094 namely Amita Chowdhary for his domestic use.

On getting information, between 11.25 hrs to 11.40 hrs. I alongwith, Sri Rudra Prasad Dutta, (LM), Sri Joygopal Debnath (TSH), Sri Abani Pandey (TSH) of Lalbazar CCC, inspected the house of Chiranjit Chowdhary (User), S/o LT Biswapati Chowdhary, Vill- Bhadul, P.S & Dist Bankura.

Seizure list was prepared at the site, representative of the accused person refused to sign.

The inspection team left the premises at Vill-Bhadul on 11:40 hrs.

The accused person has committed an offence U/S 135(i)(b) of the Electricity Act 2003 & subsequently Electricity (Amendment) Act-2007.
