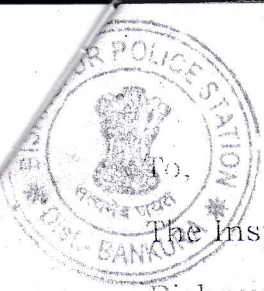

Sir,

In producing herewith following accd. person namely Ujjal Sheikh @ Rakho Sheikh(28yrs), s/o: Siddique Sheikh of Sankharibazar Manasatola [Ward:02] along with following article

1. 01 polythene packet containing supposedly narcotic substance, weighing 340 milligrams with polythene
2. 01 polythene packet containing supposedly narcotic substance, weighing 350 milligrams with polythene
3. 01 polythene packet containing supposedly narcotic substance, weighing 1gr.22 milligrams with polythene
4. 01 polythene packet containing supposedly narcotic substance, weighing 1gr. 05 milligrams with polythene
5. A mobile hand set of micromax, color: Black

I would like to draw your kind attention to the fact that today on 26.09.17 at 15:25hrs, received a secret source information that one Ujjal Sheikh @ Rakho Sheikh (28yrs), s/o: Siddique Sheikh of Sankharibazar Manasatola [Ward: 02], P.S. Bishnupur, Dist. Bankura has stockpiled narcotic drug and psychotropic substance for his own consumption and for selling. Noted the matter in GD for reference. This refers Bishnupur P.S. GDE No 1185/17, Dt. 26.09.17.

Accordingly, I informed the matter to IC Bishnupur P.S. As instructed left the P.S. with force for executing the secret source information. This refers Bishnupur P.S. GDE No. 1186/17, Dt. 26.09.17 and CC No. 5277, Dt. 26.09.17

I along with force left for Sankharibazar Manasatola [Ward:02], under P.S. Bishnupur, Dist. Bankura. I would like to note here that I took weight measuring instrument and narcotic drug identification kit with me. We arrived at the place around 16.05hrs. Cordoned off the house of the aforesaid person. As soon as we cordoned off the house, aforesaid person tried to flee away, breaking the cordon.



I disclosed my identity to aforesaid person and we were all in uniform. Also informed him the purpose of raid. Asked his name for verification. He stated his name as noted above and particulars as stated above. As I asked him to show us place of stockpiling contraband substance, he started not cooperating with us.

I, then, issued a written notice in presence of local people to him stating whether he prefers to search our persons and he denied that instant. And as he is to be searched in presence of a magistrate or a gazette officer, I informed Sri. Sukomal Kanti Das, SDPO, Bishnupur to remain present at said place as GO.

He i.e. Ujjal Sheikh @ Rakho Sheikh was interrogated without threat or inducement. In course of interrogation, he confessed that he is having 06 packets of brown sugar which he procured for self consumption and selling i.e. wrongful gain. He procured 04 packets of contraband substances from Calcutta.

Before starting inventory, preparing of seizure list and labeling, I looked for independent witnesses. Few people were there. But everyone declined to sign on seizure list. Around 16:45 hrs, Sri. Sukomal Kanti Das, SDPO, Bishnupur arrived at PO. In his presence and in presence of local people, started entire procedure of search, seizure and preparation of inventory. Aforesaid person was at PO. He was asked to produce any documents in favor of stockpiling those contraband substance and he failed in doing so. I searched his person and found 04 packets of brown sugar from the pocket of his possession. Those were identified and affirmed by drug identification kit. Those were seized accordingly.

After that, I arrested him. Issued him memo of arrest. I brought the aced. person at P.S. and typed the complaint.

Now, I pray to you to start a cog.case against Ujjal Sheikh @ Rakho Sheikh (28yrs), s/o: Siddique Sheikh of Sankharibazar Manasatola [Ward: 02], P.S. Bishnupur, Dist. Bankura u/s: 21(a) NDPS Act.
