In producing herewith the following arrested accused namely – 1) Shanawaz Alam (38Years), s/o – Lt. Badre Alam of Katandhar Bypass PS Bishnupur Dist Bankura 2) Kartik Bagdi (30Years), s/o – Lt. Kanai Bagdi of Amlasuli, PS – Goaltore, Dist-West Medinipur 3) Sunil Dey (40Years), s/o – Lt. Provakar of Modhuban, PS- Bishnupur Dist Bankura with following seized items:-

- 1. Four (04) pics of lathi made of bamboo having length of 5/6ft.
- 2. Thirty five (35) pics of bricks bats of different shape and sizes.
- 3. One (01) front guard of one blue color Maruti car no: WB-68R-8389. The front guard is made of thick sheet of metal having the length of 5/6ft approximately -

And do here by lodge a complaint as suo-motu against said arrested accuseds and 200/300 violent mob equipped mostly with lathi, aforesaid brick bats and aforesaid front guard of the car to the effect that today on 27.09.2017 myself along with my security guards were returning from Kotulpur PS after supervising law and order duty arising out of Durgapuja and going to Bishnupur PS to supervise the duty of police personnel deployed there, having boarded my Govt. vehicle. While approaching Katandhar, Basantotola under Bishnupur PS at about 20.10hrs, found aforesaid violent mob had engaged themselves in causing damage to the aforesaid car. Found S/I Biswanath Das of Bishnupur PS and force were there and the mob was so violent that S/I Biswanath Das and his man got overpowered.

I came to learn from the S/I that said Maruti car had dashed 4/5 persons rendering them injured and hospitalized and also came to learn that the driver of that car namely Gautam Chackraborty, s/o – Haripada Chackraborty of station road, SP- Bishnupur, who had taken shelter in the mobile phone shop at Katandhar Basantitola was also facing the criminal intimidation of said violent mob. I felt that if said Gautam Chackraborty was not rescued and sent to Police station then the violent mob might have lynched him. I called the duty officer over telephone at 20.15hrs and narrated the plight of ours as well as said Gautam Chackraborty and requested for reenforcement. My information was diarized vide GD entry no: 1240, date- 27.09.2017 of Bishnupur PS.

I and aforesaid officer force along with my security guards namely C / 24 Biswajit Mishra and C / 1785 Dilip Kr. Mhato tried to pacify the violent mob but all in vain. The situation demanded immediate rescue of said Gautam Chackraborty whom a large section of violent mob tried to pull out from aforesaid mobile phone shop. I with my party got hold of said Gautam Chackraborty but one unknown miscreant equipped with said metal heavy front guard of said car started assaulting him and rendered him injured, when I tried to resist him from striking another blow said miscreants again inflict one blow upon my security guard C / 1785 Dilip Kr. Mahato, and another blow on my person rendering both of us injured. Even a section of the mob manhandled me and resisted me from discharging statutory duties of a Govt Servant.

Finding no way out I declared the assembly of the violent mob as unlawful and asked them to disperse but they did not listen to it, instead they started hurling brick bats aiming at us and some of them equipped with lathi made of bamboo were coming towards us to assault us. In order to save our life, Govt. property and the life of said Gaautam Chackraborty as per my order my security guards, aforesaid S/I and his party and a contingent of force which came from Bishnupur EF Lines as per my above SOS resorted to mild lathi charge to disperse the violent mob, after lathi charge the violent mob dispersed. I Rescued said Gautam Chackraborty from the mob and sent him to Bishnupur Police station by Govt. vehicle and managed to arrest said three accuseds which were a part of stubborn violent from the place of occurrence that is Katandhar Basantitola, ps- Bishnupur. Said arrests were made from 20.35hrs to 20.50hrs by issuing memo of arrest. I conveyed the ground of arrest them and arrangement is being made to inform the relatives of the arrested accuseds through I/C Bishnupur PS and I/C Goaltore PS. From 20.55hrs to 21.10hrs I seized aforesaid items from the place of occurrence under a memo of seizure duly attested by Police witnesses and the arrested accuseds as there were no public witnesses and most of the houses were found closed. As per my order my accompanying Police personnel searched the place of occurrence and its surrounding but no other injured person could be found. After that myself with injured security guard C / 1785 Dilip Kr. Mahato had been to Bishnupur District Hospital where attending Medical Officer waited upon us and prescribed medicine and issued emergency tickets. From Bishnupur PS I came to learn that said Gautam Chackraborty has been shifted to Radhanagar BPHC for medical treatment.

The act of the aforesaid arrested accuseds and their accompanying violent mob comprising 250/300 people is liable U/S-147/148/149/341/323/325/353/307/427 IPC. So I request to lodge a FIR under above sections of law accordingly.
