Dear Sir,

I, Sri Biplab Mandi, S/o Sri Dharam das Mandi AE(E) & Station Manager Jhantipahari C.C.C, WBSEDCL being empowered by the electricity Act, 2003 and electricity (Amendment) Act, 2007 do here by lodge complaint against Surendra Tudu, S/O-Lt Dhananjay Tudu at Vill-Talsa(Dakshin Para), P.O-Sihika P.S- Chhatna, Dist- Bankura, Pin-722137 for theft of Electricity u/s- 135(1) (a) of the Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as stated here under:-

On 08.09.17 in between 3:00 PM and 3:20 PM. myself along with 1) Sri Sourav Kundu, SAE(E) S/O-Golak Kundu, Jhantipahari C.C.C 2) Sri Aniruddha Maity, S/O- Sri Aswini Kumar Maity, OE, Jhantipahari CCC, WBSEDCL, inspected the domestic premises of Surendra Tudu, S/O-Lt Dhananjay Tudu at Vill- Talsa(Dakshin Para), P.O-Sihika, P.S- Chhatna, Dist- Bankura, Pin-722137 and found that he (Surendra Tudu) was using electricity unauthorizedly and dishonestly by direct hooking through 0.5 Sqmm flexible two core wire (white color) from our near by LT OH line, As a result WBSEDCL losses revenue.

Thus it is evident that said Surendra Tudu, S/O-Lt Dhananjay Tudu at Vill- Talsa(Dakshin Para), P.O-Sihika P.S- Chhatna, Dist- Bankura, Pin-722137 has committed theft of electricity and liable for prosecution u/s 135(1)(a) of the electricity Act, 2003 and Electricity (Amendment) Act, 2007.

Then we disconnected the unauthorized connection and seized flexible Two core wire, 0.5 Sqmm-9 Mtre (approx), hooking device and prepared the inspection report and assessed the load which came to 0.100 KW (Except plug points).

So, you are requested to please treat this written complain as FIR and arrange for investigation of this case.
