Sub;-FIR against Sri Nimai Rakshit , S/O- Kamala kanta Rakshit at Vill- Murgaboni, P.O- Jhantipahari, P.S- Chhatna, Dist- Bankura, Pin- 722137 due to theft of electricity of WBSEDCL on dated 20.09.2017 at about 1:20 PM.

Dear Sir,

I, Sri Biplab Mandi, S/O- Sri Dharam das Mandi, AE(E) & Station Manager Jhantipahari C.C.C, WBSEDCL being empowered by the electricity Act, 2003 and electricity (Amendment) Act, 2007 do here by lodge complaint against Sri Nimai Rakshit , S/O- Kamala kanta Rakshit at Vill- Murgaboni, P.O- Jhantipahari P.S- Chhatna, Dist- Bankura, Pin-722137 for theft of electricity u/s- 135(1) (b) of the electricity Act, 2003 and electricity (Amendment) Act, 2007 as stated here under;-

On 20.09.17 in between 1:20 PM and 1:45 PM. myself along with 1) Sri Sourav Kundu, SAE(E) ,S/O-Golak Kundu, Jhantipahari C.C.C , WBSEDCL 2) Sri Aniruddha Maity, S/O-Aswini Kr. Maity, OE, Jhantipahari C.C.C , WBSEDCL 3) Sri Sankarprasad Goswami, S/O- Lt Upendranath Goswami, Gr.1 T.S.H, Jhantipahari CCC, WBSEDCL inspected the domestic premises of Sri Nimai Rakshit , S/O- Kamala kanta Rakshit at Vill- Murgaboni, P.O- Jhantipahari P.S- Chhatna, Dist- Bankura, Pin-722137 and found that he (Sri Nimai Rakshit) was using electricity unauthorizedly and dishonestly by bypassing the meter circuit having meter no L4688304 against Consumer ID 232133659, as a result WBSEDCL losses revenue.

Thus it is evident that said Sri Nimai Rakshit, S/O- Kamala kanta Rakshit at Vill- Murgaboni, P.O- Jhantipahari, P.S- Chhatna, Dist- Bankura, Pin-722137, has committed theft of electricity and liable for prosecution u/s 135(1)(b) of the electricity Act, 2003 and electricity (Amendment) Act, 2007.

Then we disconnected the unauthorized connection and seized one Electric heater , and two core service cable 50 ft (approx) prepared the inspection report and assessed the load which came to 2.01 KVA (Except plug points).

So, you are requested to please treat this written complain as FIR and arrange for investigation of this case.
