Sir,

I, Sri Paritosh Kumar Baidya S/O-Lt.Amulya Kumar Baidya, Station Manager Hirbandh C.C.C, WBSEDCL being authorized under the electricity Act,2003 and electricity (Amendment) Act,2007 do here by lodge complaint against Bhadra Bauri S/O. Lt. Mathur Bauri address, Vill- Sitarampur, P.O- Moshiara, P.S- Hirbandh, Dist-Bankura for theft of electricity u/s- 135(1)(a) of the electricity Act,2003 and electricity (Amendment) Act,2007 as stated here under :-

That on 08.09.2017 in between 15:10 Hrs. and 15:30 Hrs. myself along with (1)Anup Kr Kar (S.O. S & LP), Bankura Region, WBSEDCL, S/O- Lt Amiya Kar (2) Srijib Sinha (L.M.) S/o Lt Radheshyam Sinha ,(3) Shibsankar Chakraborty (T.S.H.) S/O- Lt. Joydeb Chakraborty Hirbandh CCC and others inspected the premises of Bhadra Bauri, with address as noted above on the basis of secret source information.

During inspection and checking Bhadra Bauri was using electricity unauthorized and dishonestly by direct hooking from nearby LT mains of WBSEDCL for domestic purpose causing and there by huge revenue loss to WBSEDCL. During inspection said Bhadra Bauri was not present on the spot and that's why inspection report and seizure list could not be signed and handed over to the accused.

Thus it is evident that said Bhadra Bauri S/O. Lt. Mathur Bauri address, Vill- Sitarampur, P.O- Moshiara, P.S- Hirbandh, Dist-Bankura has committed theft of electricity by direct hooking from nearby LT mains of WBSEDCL and liable for prosecution u/s 135(1)(a) of the electricity Act,2003 and Electricity Amended Act 2007.

I prepared the inspection report and assessed the load which came to 0.3 KW on the spot.

The unauthorized hooking line was disconnected as per provision of law & I seized the same by preparing seizure list.

Local witnesses refused to sign on the inspection report and seizure list .

There were other items of electrical appliances which could not be removed and sized at the time of raid. The raiding party left the site at 15.31 Hrs. on same day (08.09.2017) after completion of inspection and checking.

So, you are requested to treat this written complain as FIR, Start a case, arrest the accused and arrange investigation.
