I Sri Biswadeb Biswas, S/O- Dr. Buddhadeb Biswas, A.E & S.M Saltora CCC, WBSEDCL, P.S-Saltora, Dist -- Bankura, being empowered by the Electricity Act 2003 amended in 2007 do here by lodge complain against accused MAGA BAURI, S/O- JYOTI BAURI, of vill - TILURI, Post- TILURI, Dist- Bankura, P.S- Saltora. We have received information that the aforesaid accused person was committing theft of Electricity by hooking device from the nearest L.T.O.H pole of W.B.S.E.D.C.L. for the purpose of Domestic Consumption.

On getting this information on 16.09.2017 between 11.00 hrs to 11.15 hrs, I, along with Sri, Srideb Saha, SAE (E), of Saltora CCC and Susanta Paramanik. (O.E), of Saltora CCC. With other Technical staffs inspect the Domestic Premises MAGA BAURI, S/O- JYOTI BAURI, of vill- TILURI, Post- TILURI, Dist- Bankura, P.S.- Saltora.

It was detected that the accused person was committing theft of Electricity by hooking device from the nearest L.T.O.H pole of W.B.S.E.D.C.L. for the purpose of Domestic Consumption to commit the theft of Electricity. I prepared the Inspection report on the spot and the consumption of load was detected as 0.45k.w. Under my direction the Hooking Device was removed.

It is well evident that the accused person has committed an offence u/s 135 (1) (a) at the Electricity Act 2003 amended in 2007. As such, kindly treat this as an F.I.R.
