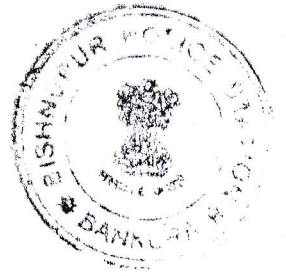

Sir,

In producing herewith arrested accused person namely Ashok Majhi (48 yrs) S/o Gopal Majhi of Gossaibari, P.O.- Chakdaha, PS-Bishnupur, Dist Bankura along with seized article 15 Pcs of Country spirit bottle, style as 'Captain', each 600 ml., Rs- 75/- (Total value 15 Pcs x Rs. 75/- = 1125/-) with proper seizure list duly sealed & leveled.

I do hereby lodged a written complaint against the above noted person that on 18.10.2017 received source information that one person was illegally selling Country spirit without any valid document and as per order of I/C Bishnupur PS to execute the information at 22:25 hrs vide Bishnupur PS GDE NO. 820/17 Dt. 18.10.2017 I along with SI Biswanath Das and town mobile officer ASI Mansa Ram Singha and force namely C/1317- Bablu Mal, N.V.F.- Sukumar Mahato vide Bishnupur PS CC. NO.5519 left the PS and at 22:45 hrs. reached at Pathikbandhu Hindu Hotel, by Govt. vehicle on Bishnupur Sonamukhi road, PS- Bishnupur, Dist- Bankura and found one Ashok Majhi (48 yrs) S/o Gopal Majhi of Gossaibari, P.O.- Chakdaha, PS-Bishnupur, Dist Bankura was keeping & selling County spirit. On being asked he disclosed his name and address as noted above. On being asked he could not able to produce any valid license or document in support of keeping & selling of Country spirit. So, he violated the rule of Bengal Excise Act. Accordingly in-between 22:45 hrs to 23:25 hrs I seized the above noted Country spirit bottle after preparing proper seizure list duly sign by the accused person and other witnesses and arrested the accused person in-between 23:30 hrs to 23:35 hrs after observing proper arresting procedure.

I therefore pray that legal lawful action may kindly be taken against him.
