Sub: Complain (F.I.R) against some unknown persons for my wrongful interception snatching and punched with fist and blow on dated 17/10/2017 at 10 a.m.

Respected Sir,

1, Ashok Kumar Mishra, Aged 51 years, working in Commercial department holding designation Sr. A.G.M.(Commercial) at Rohit Ferro Tech Ltd. ,having its plant at Bishnapur in Bankura

On 17/10/2017 at 9.30 A.M. as usual course of my job and responsibility I was on the way to my office. Suddenly, some goons/ unknown persons stopped the car in which I was going to office at Dwarika More and they wrongfully detained me. That time the reason was unknown to me. When I casked their identification and reason for my wrongful detention they become furious by using unpadiamentary words and showed their assaulting action. Thereafter one person among them put his hand into my shirt's front pocket and looted Rs.18,000/- (Rupees Eighteen Thousand Only) which i kept for purchasing on the occasion of Dipawali. Another person in the mob snatched gold chain from my neck weighing 32 grams amounting to rupees Rs. 30,000/- (Rupees thirty Thousand) approx (PURCHASED IN 2006). In the mean time some person started slapping and kicking me on my face hear my left ear and rest of the goons started punching me with their fist blow and leg. As a result ! fell down but they continued their hitting and beating. Their intention was to murder me on the spot. I was even unable to call any one for help. Our H.R.Head contacted I.C. Bishnupur over phone and requested him to send the force immediately to rescue the trapped staff and myself, accordingly my life was saved by the police officer. The said police officer escorted me up to the RFTL office and he was with me in my chamber for about half an hour. Before this incident our entire plant staff along with Managerial Staffs vehicle were also stopped intercepted and detained by these mob with dire

My comprehension about this incident tells me that this incident took place due to some reason which was related to our company. Our company's production has stopped since last 3 years and now management is in process to retranchment of contractual labour. So to stop that process they acted in such a way that this incident took place. There were many unsocial elements that were

involved in this mob and harmed me by slapping, punching, kicking and by looting me as mentioned above. The reason behind my thought about happening of this incident is that, just after reaching in office with the said police officer, some political leaders along with some village people and labour of Dwarika, came to my chamber and they started talking about their demands. Their demand were to

stop the retrenchment, early payment etc.

I was so damaged with this unexpected and uncalled occurrence that compelled me to go to Bishnupur hospital. Doctors prescribed X-ray for ears and CT Scan, admitted me under their observation upto 24 hours. A copy of report and prescription is enclosed with this complain and on the same day a general diary entry was made, G.D. No. being 747 dated 17/10/2017, a copy of general diary is enclosed with this complain. Now the entire staff/ Managers are panicky and they are traumatized and getting apprehended to do their duties, so you are requested to protect us from the hooliganism.

In view of the above said facts and circumstances, I humbly request your good self to lodge F.I.R., investigate into the matter recover my gold chain being wtd-32 gm , amounting to Rs. 30,000/- and cash of Rs. 18,000/- by initiating strict legal action against the person/s responsible for this occurrence.
