 aforaid arrested and who told their
 name & address as mentioned above, from the
 board. I got aforaid cash and playing
 cards along with bottle of Alcoholic drink
 glass and the Mobile Phone.
 on being asked the arrested aed said
 that, aforaid Motorcycles and scooter do
 belong to the gamblers who managed to
 escape and said motorcycles & scooters
 were used by the gambless to reach;
 so this club which is used as a common
 gaming house at the cost of Rs. 1000/- per
 day.

from 23.25 hrs to 23.58 hrs. I seized the aforesaid items as aforesaid of this case under a memo of seizure duly attested by Police act mess (as local people exposed their insecurity in attesting the seizure list) and the aforesaid arrested a/cd. from 00.05 to 00.20 hrs I arrested the aforesaid a/cd as they were liable as per provision of section 3/4 of West Bengal Gambling and Prize Competition Act. I issued memo of arrest to them. Informed their relatives regarding the arrest.

From the above fact it is evident that, aforesaid arrested a/cd, the registered owners of aforesaid motor cycle & scooter and the gamblers who escape are liable on the section 3/4 of West Bengal Gambling & Prize Competition Act.

Hence, I request you to register an FIR against said arrested a/cd, the registered owner of seized motor cycle & scooter and the miscreant who managed to escape vs 3/4 West Bengal Gambling & Prize Competition Act, and initiate a regular investigation.


