## Sub:-Complaint

Sir,

With due respect I SI Koushik Hazra now posted at Sonamukhi PS engaged in L/O duty at Bankura PS in c/w Durga Puja 2017 as per order of S.P Bankura vide org no 2348/RO dt. 26.09.17. On 27.09.17 at about 19.25 hrs when I along with force vide C.C no. performing my lawful duty arrived at 1st Feeder road Rabindra Sarani, observed a massive jam from Station more to Bankura PS. When I enquired the reason behind that jam, I found that (1) Soumen Singh @ Chhotu S/O- Not Known (2) Ramkrishna Adhikary (3) Tara Sankar Bandyopadhyay (4) Ashoke Kr. Banerjee (5) Tarun Kundu and many others, all of Rabindra Sarani PS & Dist-Bankura were setting off fire crackers obstructing the road caused very much trouble for the devotees from entering in the Puja pandal. Accordingly I chase them and dispersed them to clear up the road for smooth entering of devotees at the Puja pandals. But they stopped me and prevented me from performing my Lawful duty using filthy languages and gestures. Some how me and my force managed to clear up the road mean while those trouble mongers flew away from that spot.
