Sir,

I Chandan Dutta, S/o. Late Amarendra Nath Dutta, resident of type II/13, Quarter No.31 Railway Colony, Durgapur-01 beside Durgapur Railway Station, Dist. Paschim Bardhaman most respectfully beg to inform you that on 26.10.17 at about 6.35 P.M. at Durgapur Barrage Kachha Road when I alongwith my two daughters, one of my neighbour Anirban Roy and his mother was going on Barrage for Chhat Puja occassion, one Tata Ace Vehicle being registration No. WB-39A 5330 dashed my daughter Subhashree Dutta from behind due to rash and negligent driving of the driver of said vehicle. Due to such accident my daughter received injury in the entire left side from neck to toe and on that day she was medically treated at Vivekananda Hospital Bidhannagar and on 27.10.17 she was further medically treated by Dr. Avijit Nag at Jeevan Deep Nurshing Home and she is under treatment of Dr. Nag and she is completely bed ridden. ~~xxxxxxx~~ Due to rash and negligent driving of the driver of the vehicle the said accident occurred.
