I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Tapas Dutta, S/o Lt. Jyanendranath Dutta of Vill- Lalbazar(kalla), P.O- Beliatare, PS- Barjora Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today 13.10.2017 at about 3:10 PM, I along with 1) Sri Arup Kumar Kar, S.O, S&LP wing, Bankura Region 2) Sri Singrai Tudu, HG, T.S.H, S&LP wing Bankura Region, 3) Sri Subhadeep Roy, S.A.E (E) 4) Gangadhar Mondal, L.M WBSEDCL inspected the domestic Premises of Sri Tapas Dutta of Vill- Lalbazar (Kalla), P.O- Beliatare, PS- Barjora Dist- Bankura.

During inspection it was detected that Sri Tapas Dutta committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use & observed load 0.2 kw. (2 nos fan, 2 nos CFL) Inspection report was prepared at spot with the signature of Sri Tapas Dutta (accused) and local people were asked for signature but they refused.

I directed the Sri Gangadhar Mondal , L.M to remove the hooking cable from LTOH line.

I seized some portion of the hooking cable & prepare seizure list with the signature of Sri Tapas Dutta (accused) at spot.

It is well proved that the accused Sri Tapas Dutta, S/o Lt. Jyanendranath Dutta is liable for prosecution as committed theft of electricity under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
