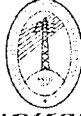

I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sk Jobed, S/o Lt Sekh Nabib Vill-Lalbazar, P.O- Beliatare, PS- Beliatare Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today 17.10.2017 at about 01:30 PM, I along with 1) Sri Subhadeep Roy, S.A.E (E) 2) Abdul Kashem, L.M, 3) Alope Nath Karmakar, Hg Sr L.M 4) Satyapada Roy, Hg TSH 5) Sumanta Danguria, TSH all of them of Beliatare CCC inspected the domestic Premises of Sk Jobed, S/O- Lt Sekh Nabib, Vill-Lalbazar, P.O- Beliatare, PS- Beliatare Dist- Bankura.

During inspection it was detected that Sk Jobed, S/o Lt Sekh Nabib, Vill- Lalbazar, P.O- Beliatare PS- Beliatare Dist- Bankura committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 201339352 by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use as a result the energy consumption was not recorded. Observed load 0.66 kw (1 nos 100w lamp, 3 nos CFL, 2 nos fan, & 1 no water pump)

Inspection report was prepared at spot with the signature of accused Sk Meraj, S/O Sk Jobed(Accused). Local people were asked for their signature on the inspection report but they refused.

I directed the technical staff to remove the hooking cable from LTOH line and also disconnect the existing permanent service line bearing consumer ID 201339352.

I seized some portion hooking cable, one nos 100 watt lamp and prepare seizure list at spot. we left the spot on at 1:50 PM.

It is well proved that the accused Sk Jobed, S/O- Lt Sekh Nabib is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
