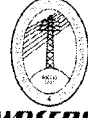

Dear Sir,

I Sri Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatore Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Bhim Gorai , S/O of Lt Baul Gorai of Vill-Beliatore (Namopara), P.O-Beliatore, PS- Beliatore Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today on 12.10.2017 at about 01.20 PM, I along with 1) Sri Subhadeep Roy, S.A.E (E) 2) Alope nath Karmakar, Hg. Sr L.M, 3) Gangadhar Mondal, L.M, 4) Yuddhapati Das, Hg TSH, 5) Satyapada Roy, Hg TSH 6) Sumanta Danguria, TSH all of them of Beliatore CCC inspected the domestic Premises of Sri Bhim Gorai of Vill-Beliatore (Namopara), P.O- Beliatore, PS- Beliatore Dist- Bankura. During inspection it was detected that Sri Bhim Gorai committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use & observed load 0.16 kw.(1 nos fan, 100watt lamp) Inspection report was prepared at spot with the signature of Bhim Gorai (accused) and local people were asked for signature but they refused.

I directed the Sri Gangadhar Mondal , L.M to remove the hooking cable from LTOH line.

I seized some portion of the hooking cable & prepare seizure list with the signature of Bhim Gorai(accused) at spot.

It is well proved that the accused Bhim Gorai, S/o Lt Baul Gorai is liable for prosecution as committed theft of electricity under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
