

Sub:- Prayer for lodging an FIR.

Sir,

With due respect and humble submission I, SI Bhairabananda Goswami beg to report that on 09.07.17 at 20.25 hrs one Nitai Mondal s/o- Ganesh of Amlabaid, PS- Beliatore, Dist- Bankura submitted a written information to the effect that on 09.07.17 afternoon one Khandi Murmu (62 yrs) w/o- Badal Murmu of Shyamfelia, PS- Beliatore, Dist- Bankura died due to unknown caused and the body sent to the cremation ghat for funeral work by her family members. But on suspicious ground the complainant lodge the complaint and over this started Beliatore PS U/D case No- 15/17 dtd- 09.07.17 and as per kind order and endorsement I took up is enquiry.

During preliminary investigation I along with accompanying C/1371 Abhijit Mahanta went to the village Shyamfelia and prepared inquest over the dead body of deceased Khandi Murmu. During inspection, injuries found in the body of the deceased but none reported any complaint regarding any foul play behind the death of Khandi Murmu. However, to ascertain actual cause of death I send the dead body to BSMCH Morgue, Bankura for PM examination with inquest report and other connected papers. Also conducted local enquiry and it came to learnt that Khandi Murmu was physically assaulted by some unknown person as such she received injuries on her body and succumbed to death but none could say anything about the actual incident.

During investigation today on 16.10.17 received original PM report from B.S.M.C.H. Bankura vide PM NO- 664/17 dt- 10.07.17 . Perused the PM report in which attending Dr. Tanoy Mohanta opined that "Death was due to effects antemortem injuries, as noted above — Homicidal in manner. Further opinion, if any may be given after receipt of CE's reports. As such it is reasonably believed that there is foul play behind the death of deceased Khandi murmur(62 yrs) w/o- Lt. Badal Murmu of Shyamfelia, PS- Beliatore, Dist- Bankura.

Under the above circumstances I pray that a specific case may kindly be started against unknown miscreants for proper investigation over the death of deceased Khandi Murmur (62 yrs) w/o- Lt. Badal Murmu of Shyamfelia, PS- Beliatore, Dist- Bankura and oblige.
