I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Sarat Ghosh(User), S/o Bagala Prasad Ghosh Vill-Goswamipur, P.O- Beliatare, PS- Beliatare Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today 07.11.2017 at about 01:10 PM, I along with 1) Sri Subhadeep Roy, S.A.E (E) 2) Abdul Kashem ,L.M, 3)) Satyapada Roy, Hg TSH 4) Sumanta Danguria, TSH all of them of Beliatare CCC inspected the domestic Premises of Sri Sarat Ghosh(User), S/O- Bagala Prasad Ghosh, Vill-Goswamipur, p.o- Beliatare, PS- Beliatare Dist- Bankura having Consumer ID 232022456

During inspection it was detected that Sri Sarat Ghosh(User) committed theft of Electricity dishonestly bypassing the energy meter bearing meter no P198840 of WBSEDCL by tapping the incoming service cable(before Meter). As a result the energy consumption was not recorded in that said meter. Observed load 0.8 kw (1no water pump , 2nos fan, 2 nos 100w lamp, 1 no TV)

Inspection report was prepared at spot with the signature of Jyotsna Ghosh w/o accused Sarat Ghosh(user) . I directed the technical staff to remove the Tapping cable from the service line and also disconnect the existing permanent service line bearing consumer ID 232022456. I seized some portion hooking cable, one nos 100 watt lamp and prepare seizure list at spot. we left the spot on at 1:40 PM.

It is well proved that the accused Sri Sarat Ghosh (User), S/O- Bagala Prasad Ghosh is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
