Sub: Complain against Madhumoy Bhattacharya, S/o Late Ramjibon Bhattacharya, Vill Bhattapara, P.O Bhattapara, PS Beliatare, for theft of Electricity by tapping of service Line (before energy meter having consumer ID 201817689) of WBSEDCL.

Sir,
I Biswanath Dey, S/O- Harekrishna Dey, aged about 30 years, A.E. & Station Manager of the Beliatare Customer Care Centre being authorized under the Electricity Act. 2003 and Electricity (Amendment) Act-2007, do here by lodge complaint against Madhumoy Bhattacharya, S/o Late Ramjibon Bhattacharya, Vill -Bhattapara, P.O.- Bhattapara, P.S-Beliatare, Dist- Bankura for theft of electricity for his domestic need by tapping service cable before meter(having consumer ID 201817689) with the PVC wire. So, Madhumoy Bhattacharya committed theft of electricity and liable for prosecution U/S.-135(i)(a) of Electricity Act 2003 and Electricity (Amendment) Act-2007, as Stated here under.

That on 07.11.2017 in between 14:55 Hrs. and 15:25 Hrs. myself along with (i) Surjeswar Sen, S/o Late Guruprosad Sen, SE(E), Bankura Regional Office (ii) Anup Kr Kar, S/o Late Amiya Kar, SO, S&LP, Bankura Regional office, iii) Bikash Kr Mondal, S/o Nalini Kanta Mondal, SAE(E), G.ghati CCC, iv) Sanat Hansda, S/o Late Sonatan Hansda, L.M. G.ghati CCC v) Singrai Tudu, Sr TSH of Bankura Regional Office and others on the basis of secret source of information inspected the domestic premises of Madhumoy Bhattacharya, S/o Late Ramjibon Bhattacharya, Vill Bhattapara, P.O.-Bhattapara, P.S- Beliatare, Dist- Bankura and found that said Madhumoy Bhattacharya was using electricity unauthorizedly and dishonestly in their domestic premises by tapping service cable before meter with the help of PVC wire that causing huge loss of revenue of WBSEDCL. So Madhumoy Bhattacharya committed theft of electricity and liable for prosecution U/S.-135(i)(a) of Electricity Act-2003 and Electricity (Amendment) Act-2007.

I prepared the inspection report and assessed the load which comes to 0.380 KW. The unauthorized service cable was disconnected as per rule of WBSEDCL with the help of technical staff and seized part of service cable and prepared seizure list. The inspection team left the site at 15:25 hours on 07.11.2017.

So you are hereby requested to treat this complaint as F.I.R.
