On getting information, between 12.35 hrs to 12.48 hrs. I along with, Sri Agnishwar Chakraborty (TSH), Sri Abani Pandey (TSH), Manas Giri, O.E. of Lalbazar CCC, inspected the house of Tarun Kanti Shit, S/o LT Gora Chand Shit, Vill- Pratappur, P.S & Dist Bankura.

During inspection it was detected that the accused Tarun Kanti Shit, S/o LT Gora Chand Shit, Vill- Pratappur, P.S & Dist Bankura has committed theft of electricity by bypassing the energy meter with shorting the incoming & outgoing terminal of connected energy meter having consumer ID 232072229 as energy consumption is not recorded in the energy meter.

I prepare the inspection report at site and assessed load of 0.584 KW. I directed Sri Abani Pandey (TSH), to disconnect the said meter from service mains and disconnect the premises from It mains of Con ID 232072229.

From the above arrangement he was using the following electrical equipments.

1) Domestic Fridge 1 no. @ 180 watt, 2) Fan 3nos. @ 80watt, 3) CFL 6 nos. @ 14watt, 4) Colour T.V. 1 nos. @ 80 watt.

Out of which I seized the following -

1) Existing energy meter (Make- Accurate meters ltd, SL No. AS380327) one number fitted with teak wood based and with small conductor which are used for shorting the incoming & outgoing terminal of said meter.

Seizure list was prepared at the site, representative of the accused person refused to sign.

The inspection team left the premises at Vill- Pratappur on 12:49 hrs.

The accused person has committed an offence U/S 135(i)(b) of the Electricity Act 2003 & subsequently Electricity (Amendment) Act-2007.
