On getting information today on 15.11.2017 at about 2:30 PM,I along with 1) Sri Subhadeep Roy, S.A.E (E) 1) Gangadhar Mondal, A.C.M 2) Abdul Kashem,L.M 3), 4) Yuddhapati Das, Hg TSH, 5) Satyapada Roy, Hg TSH 6) Sumanta Danguria, TSH all of them of Beliatore CCC inspected the domestic Premises of Sri Aloke Kha of Vill-Nirisha(Akure Para),P.O- Beliatore, PS- Beliatore Dist- Bankura.

During inspection it was detected that Sri Aloke Kha committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use & observed load 0.2 kw.(1no fan, 1 no 100watt lamp, 2 nos cfl lamp)


Inspection report was prepared at spot with the signature of Sri Aloke Kha(accused) Local people were asked for signature but they refused.
