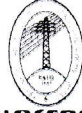

I Sri Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliature Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri Alope Kha, S/O Madan Kha of Vill-Nirisha(Akure Para), P.O-Bhattapara, PS- Barjora Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today on 15.11.2017 at about 2:30 PM, I along with 1) Sri Subhadeep Roy, S.A.E (E) 1) Gangadhar Mondal, A.C.M 2) Abdul Kashem ,L.M 3), 4) Yuddhapati Das, Hg TSH, 5) Satyapada Roy, Hg TSH 6) Sumanta Danguria, TSH all of them of Beliature CCC inspected the domestic Premises of Sri Alope Kha of Vill-Nirisha(Akure Para), P.O- Beliature, PS- Beliature Dist- Bankura.

During inspection it was detected that Sri Alope Kha committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his Domestic use & observed load 0.2 kw.(1 no fan, 1 no 100watt lamp, 2 nos cfl lamp)

Inspection report was prepared at spot with the signature of Sri Alope Kha (accused). Local people were asked for signature but they refused.

I directed the Sri Gangadhar Mondal, A.C.M to remove the hooking cable from LTOH line.

I seized some portion of the hooking cable & prepare seizure list with the signature of Sri Alope Kha (accused) at spot.

It is well proved that the accused Alope Kha, S/o Madan Kha is liable for prosecution as committed theft of electricity under Section 135 (1) (a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain and treat this letter as F.I.R.
